Taipei Municipal Xihu Elementary School Regulations for the 2022 Academic Year Bilingual Education Class Application

A. Applicant Eligibility: For students whose household registration or residence is in Taipei City, if one of the conditions stated below is qualified, the application to enter the Bilingual Education Class is allowed.

(Applicants who meet Article 4 in "Act for the Recruitment and Employment of Foreign Professionals", Foreign professional, child(ren) of Foreign special professional and Foreign senior professional. Child(ren) of applicants who meets "Regulations for Studying in Taiwan for Children of Outstanding Overseas Scientific and Technological Personnel").

- a. Child(ren) of the company representative of foreign-invested companies, researcher, and returned scholar in Neihu Science and Technology Park.
 - 1. Foreign invested company of Neihu Science and Technology Park: Representative of the companies in Neihu Science and Technology Park approved by relevant agencies.
 - 2. Contract-based foreign researcher of the companies in Neihu Science and Technology Park.
 - (1) Researcher being contract-based employed by the companies in Neihu Science and Technology Park.
 - (2) Term employment period: Not less than one year (included).
 - 3. Contract-based returned scholar of the companies in Neihu Science and Technology Park.
 - (1) Researcher being contract-based employed by the companies in Neihu Science and Technology Park.
 - (2) Term employment period: Not less than a year (included).
 - (3) Period of staying overseas: More than three years.
 - (4) The child(ren) should also stay continuously in overseas countries for

more than two years (must apply within one year after the child(ren) returned).

b. Child(ren) of Academia Sinica's foreign researcher, returned scholar, and foreign doctor.

- 1. Contract-based foreigner employed by Academia Sinica, period of term employment is not less than a year (included).
- 2. Returned scholar being contract-based employed by Academia Sinica.
 - (1) Term employment period: Not less than a year (included).
 - (2) Period of staying overseas: More than three years.
 - (3) The child(ren) should also stay continuously in overseas countries for more than two years (must apply within one year after the child(ren) returned).
- 3. Foreign doctor of Academia Sinica: the certificate of enrollment of the current semester.
- c. Child(ren) of the company representative of the foreign-invested company, researcher, and returned scholar in Nankang Software Park.
 - 1. Foreign-invested companies of Nankang Software Park: Representative of the companies in Nankang Software Park approved by relevant agencies.
 - 2. Contract-based foreign researcher of the companies in Nankang Software Park.
 - (1) Researcher being contract-based employed by the companies in Nankang Software Park.
 - (2) Term employment period: Not less than a year (included).
 - 3. Contract-based returned scholar of the companies in Nankang Software Park.
 - (1) Researcher being contract-based employed by the companies in Nankang Software Park.
 - (2) Term employment period: Not less than a year (included).

- (3) Period of staying overseas: More than three years.

 The child(ren) should also stay continuously in overseas countries for more than two years (must apply within one year after the child(ren) returned).
- d. Others: Child(ren) of the foreign researcher of Taipei Municipal's public or private research institutions.

Term employment period: Not less than a year (included).

B. How to apply?

- 1. Please complete the attached application form by the application deadline and submit the documents below.
 - a. Household registration or passport information of parents and the child(ren) and the Alien Resident Certificate.
 - b. Returned scholar must provide documents to prove that the child (ren) stayed in overseas countries for more than two years.
 - c. Certificate of Employment of the service unit (position title and term employment period).
 - d. Child (ren)'s grade report of the original school. (Not for Grade 1).
- 2. Preliminary Review: This can be conducted in the service unit
 (Administration Office of Neihu Science and Technology Park, Academia
 Sinica and Administration Office of Nankang Software Park, and Human
 Resource Department of other organizations). Those who meet the
 requirements will be listed, tabulated, and sent to Xihu Elementary School to
 apply for a secondary review.
- 3. Secondary Review: The results will be approved by the Enrollment Examining Committee of the Bilingual Education Class after reviewing the preliminary review documents.

C. Vacancy

There is one bilingual class in Xihu Elementary School. 12 students per class.

D. Enrollment

- 1. If the number does not exceed the approved number of students, people who meet the qualifications and have been examined and approved by the Bilingual Education Class Examining Committee will be admitted.
- 2. If the approved number of students is exceeded, admission will be made in the following order:
 - (a.) Representative of the foreign-invested company of Neihu Science and Technology Park, contract-based foreigner researcher employed by Academia Sinica, child(ren) of representative of foreign-invested companies of Nankang Software Park.
 - (b.) Researcher of the foreign-invested company of Neihu Science and Technology Park, returned scholar being contract-based employed by Academia Sinica, child(ren) of the contract-based researcher of Nankang Software Park.
 - (c.) Returned scholar being contract-based employed by Neihu Science and Technology Park, child(ren) of the returned scholar being contract-based employed by Nankang Software Park.
 - (d.) Child(ren) of foreign doctor of Academia Sinica
 - (e.) Child(ren) of the foreign researcher of Taipei Municipal's public or private research institutions.
- 5. If the number of students with the same qualification is more than the admissible, preference is given to children with English and American backgrounds. If the number of students exceeds, preference is given to the application within one year upon their children's return to Taiwan. Names on the candidate list will be reserved for one semester.

E. Deadline of Application

- 1. Routine Application: Apply before the end of March each year (enrollment review will be conducted in mid of April), the date will be announced by Xihu Elementary School.
- 2. Mid-term Application: Mid-term Applications will be handled according to the regulations. If there is any vacancy, the replacement process will be conducted according to the candidate list(waiting list) of the routine and mid-term application in sequence.

The sequence of the candidate replacement: If any student leaves or transferring in the mid-term, the replacement process will be conducted according to the candidate list of the routine and mid-term applications in sequence.

Period of retention: will be due by the last day of the semester of application.

F. Teaching Implementation

- 1. Class grouping: Classes are arranged appropriately according to age.
- 2. Class periods: According to the related regulations of the Department of Education Taipei City Government.
- 3. Teaching Subjects and Methods
 - a. Bilingual Education Class Teaching Subjects: taught in English by bilingual teachers, aiming at language art, math, and science. There will be group teaching, and groupings are based on actual academic competence.
 - b. Other subjects: Participate in-class learning activities in the homeroom class.
 - c. Remedial Education: On language, math, and science, based on student's needs.
 - d. Assessments: student's grade is conducted according to "Taipei Municipal Elementary School's Grade and Assessment Supplementary Regulations".

G. Bilingual Education Class student's registration will be incorporated with HHUPS's registration; daily routines and rules are the same as the regular class students.

- H. All the documents submitted by the applicants must be genuine. If not, the applicants are responsible for against the law. In that case, students who have been admitted will be disqualified.
- I. This program has been discussed and approved by the Enrollment Examining

 Committee of the Bilingual Education Class, implemented after the approval of
 the Department of Education Taipei City Government.
